स्पीड गवर्नर निर्माताओं से आवेदन आमंत्रण हेतु सार्वजनिक सूचना

जैसा कि माननीय उच्चतम न्यायालय स्पीड गवर्नर की फिटमेंट को देख रही है एवं सेंट्रल मोटर व्हीकल रूल्ज 1989 के रूल 118 के संशोधन के द्वारा 01.10.2015 से ट्रांसपोर्ट व्हीकल की विभिन्न श्रेणियों हेतु स्पीड गवर्नर की फिटमेंट अनिवार्य करते हुए अधिसूचना सं. 290(ई) दिनांक 15.04.2015 केंद्र सरकार ने जारी की है।

अतः स्पीड गवर्नर की फिटमेंट जोकि सेंट्रल मोटर व्हीकल रूल्ज 1989 के रूल 126 अधीन अपेक्षित अनुसार टेस्टिंग एजेंसियों द्वारा प्रमाणित एवं एआईएस: 018/2001 नार्म्स सहित अनुपालन में हो, अनिवार्य एवं तदनुसार हैं। योग्य स्पीड गवर्नर निर्माता जिनके पास टाइप अप्रूवल सर्टीफिकेट्स (टीएसी) एवं कन्फर्मिटी ऑफ प्रोडक्शन (सीओपी) उपरोक्त मानकों तक है, राज्य में अधिसूचित परिवहन वाहनों के स्पीड गवर्नर की फिटमेंट हेतु यैनलबद्धता हेतु आवेदन जमा करने को आमंत्रित हैं।

स्पीड गवर्नर निर्माताओं द्वारा आवेदन के साथ संलग्न किए जाने वाले दस्तावेजों (योग्यता पात्रता अनुसार सूची देखें) की सूची एवं अन्य जानकारी कार्यालय, राज्य परिवहन आयुक्त, पंजाब, एस्.सी.ओ. नं. 177-178, सैक्टर-17सी, चंडीगढ़ से किसी भी कार्यदिवस पर 29.12.2016 से पूर्व सायं 3.00 बजे तक रु.500/- के नकद भुगतान पर प्राप्त कर सकते हैं। वहीं विभाग की वेबसाइट www.punjabtransport.org से भी डाऊनलोड किया जा सकता है एवं बैंक लिस्ट अनुसार अपेक्षित दस्तावेज सहित आवेदन एवं अधोहस्ताक्षरी के कार्यालय में जमा किए रु. 500/- की फीस रसीद 29.12.2016 से या पूर्व सायं 5.00 बजे तक व्यक्तिगत तौर पर या डाक द्वारा मोहरबंद लिफाफे पर "स्पीड गवर्नर की फिटमेंट हेतु अनुमोदन हेतु" लिखकर जमा किया जा सकता है। नियत समय के पश्चात प्राप्त आवेदन शामिल नहीं किए जाएंगे।

इस संबंध में परिवहन आयुक्त अथवा उनके द्वारा अधिकृत अधिकारी का निर्णय अंतिम एवं सभी के लिए बाध्यकारी होगा। राज्य परिवहन आयुक्त, पंजाब के पास बिना कोई कारण बताए किसी या सभी आवेदनों को रद्द करने का अधिकार आरक्षित है।

Eligibility Criteria for Registration of Manufacturers for supply & installation of Speed Governor in the State of Punjab:

Mandatory Criteria:	
1	<p>The Manufacturer must be an Indian Company and registered with the Registrar of Companies as per Company Act 1956 and shall have all approvals for its product in the State.</p> <ol style="list-style-type: none">1. Copy of Company Incorporation2. Copy of Memorandum of Associations3. Copy of PAN Card4. Copy of Sales Tax/VAT Registration of the Manufacturing Plant and of Punjab Branch5. Manufacturing Address6. Copy of Excise Registration
2	<p>The manufacturing company should be an ISO/TS 16949 company from authorized agency.</p>
3	<p>The company must comply with EMI/EMC as per the standards of AIS 004 (Part 3) 2009 in compliance to the MoRT&H guidelines dated 16th June, 2016:</p> <ol style="list-style-type: none">1. Speed Limitation Device to comply with the standard of AIS 004 (Part 3) as amended time to time for Electro Magnetic Interference/Electro Magnetic Compatibility.2. Speed Limiting Device (SLD) to be fitted shall be verified for the markings in the shape of sticker having barcode containing following information -<ul style="list-style-type: none">• The trade mark/ manufacturer emblem• The serial number assigned by the manufacturer.• Unique Alphanumeric number (six characters) of the type approval shall be indicated.

4	Type approval and Serial number of the Speed Limiting Device shall be integrated with the VAHAN database.
5	<p>As per the MoRT&H Guidelines dated 16th June, 2016 The Manufacturer has to:</p> <ul style="list-style-type: none"> • Provide comprehensive and complete solution for the implementation for MIS software to provide full transparency in the system. Sample forms for MIS submission are attached. • Follow due process and issue a fitment certificate issued by the Transport Commissioner and duly signed by the RTO/MVI. Sample certificate is attached.
6	<p>The manufacturer to provide a sticker of standardized size of 100mmX60 mm has to be fixed on the left upper side of front windscreen from inside indicating the set speed limit in a circle of 55 mm and the balance space to be used for the information as mentioned above. Destructible sticker containing the information of marking as mentioned above shall be fixed on the windscreen for quick audit purposes without reference to RC book”.</p>
7	<p>Sales & Service Network in Punjab:</p> <p>The Company must have Sales, Fitment and Service Network in Punjab.</p> <ol style="list-style-type: none"> 1. Details of Branch Address with Contact Person 2. Details of Dealer Network with Contact Details.
8	<p>Manufactures should have type approved Speed Governors models suitable for fitment in mechanically & electronically controlled engines and different fuel types.</p> <p>Type Approval Certificates from authorized testing agencies for the different models of Speed Governors manufactured by the Company.</p> <ol style="list-style-type: none"> 1. Suitability to be demonstrated to the Department of Transport (if required).
9	<p>Conformity of Production certificates as per AIS 037:</p> <ol style="list-style-type: none"> 1. Type Approval certificate for the type approved speed governors to be furnished.

10	<p>Proof of award of tender by STU/Govt. Department, excluding Public Sector Undertakings. The manufacturer must have supplied speed governors to at least one STU/Govt. Department by means of tender directly or through its authorized dealer for a minimum quantity of 1000 Nos.</p> <p>1. Copy of Rate contract/LOI/Agreement/PO along with sales invoice as proof of supply to be submitted.</p>
11	<p>Installed Production Capacity: Minimum 10000 Nos./ per month for the state of Punjab.</p> <p>1. Declaration regarding installed Production Capacity to be furnished.</p>
12	<p>Turnover of the Company:</p> <p>Rupees 25 Crores cumulative in the last three financial years from the business of manufacturing, sales and service of Speed Governors in India.</p> <p>1. Details of Turn-Over from the business of manufacturing & selling Speed Governors in India.</p> <p>2. Copy of Audited Balance Sheet and IT Returns for the last 3 years for 2013-14, 2014-15 and 2015-16.</p>
13	<p>Net Worth of Manufacturer:</p> <p>Net worth of the manufacturer must not be less than Rs 20 Crores in India as on the FY ending March, 2016</p> <p>1. Certificate from Chartered Accountant certifying the net worth.</p> <p>2. The Manufacturer who on being selected in the State of Punjab for supply of Speed Governors must provide a Bank Guarantee Any Nationalized Bank) for Rs 50 lakhs. The Performance guarantee shall be released to the manufacturer upon the completion of 90 days after expiry of the date of empanelment</p>
14	<p>Proof of Sales statement certificate: Proof of Sales statement certificate for a minimum of 30000 speed governors sold in India in the last three financial years (2013 & 14, 2014 &15 and 2015 & 16) certified by Auditor.</p>

15	<p>List of vehicle base approvals for speed governors for vehicles covered under the MoRT&H notification dated 15th April, 2015.</p> <ol style="list-style-type: none"> 1. Minimum 125 base approvals for speed limits of 60/80 Kmph out of which minimum 50 base model approvals required for a speed limit of 80 Kmph.
16	<p>Sample of Speed Governors: The manufacturer has to submit the samples of different models of Speed Governors intended for fitment in the state of Punjab.</p>
17	<p>Any Manufacturer whose approval/ operations with respect to Speed Governors have been suspended/ cancelled/ blacklisted by any state government/ central government would not be considered in the registration process.</p>
18	<p>The manufacturer must not have been prosecuted or convicted and no investigation is pending against such manufacturer for infringement of Intellectual Property Rights of any third party or entity under the provisions of Patent Act, Copyright Act and/ or Trademark Act as the case may be with regard to Speed Governor being manufactured by it.</p> <ol style="list-style-type: none"> 1. An undertaking in the form of an Affidavit to this effect to be submitted.
19	<p>Manufacturers with proven competence will be eligible for empanelment for a period of five years, which can be extended after satisfaction of the department for one more year through mutual consent.</p> <p>However, the selected manufacturers finalized through this process would remain valid for the period of empanelment/extended empanelment.</p> <p>The Transport Department reserves the right to cancel/suspend the approval/permission granted to the manufacturer for supply and fitment of speed governors in the state/allotted districts if the details/information provided by the manufacturer at the time of registration is found to be false, misrepresented or suppressed and the selected manufacturers dies, not meet the terms & conditions of the registration.</p>

20	Empanelled manufacturers have to submit monthly installation progressive report to the department as per the format annexed.
21	<p>Suspension:</p> <p>Department may by written notice of suspension to manufacturer of the empanelment, suspend the empanelment if the manufacturer or its authorized dealer fails to perform any of its obligation (including the carrying out of the services) provided that such notice of suspension shall not be issued unless a</p> <ul style="list-style-type: none"> i. Shall supply the nature of the failure; and ii. Shall request the manufacture to remedy such failure within a period from the date of receipt of such notice of intention to suspend by the manufacturer. The specified period shall ordinarily be 30 days or more, and in no case, be less than 15 days. If the manufacture is in material breach of conditions of the empanelment, State Government shall be entitled in its sole discretion and without prejudice to its other rights and remedies including its right of termination hereunder, to: iii. Suspend all or any of the rights of the manufacture under empanelment <p>Provided that no such suspension notice shall be issued without first giving the adequate notice of such intension and an opportunity to be heard.</p> <p>The suspension of the rights of the manufacturer by State Government shall be revoked by the State Government forthwith upon having remedied the material breach during such suspension period to the satisfaction of the State Government</p>
22	The Manufacturer selected for empanelment shall not change the ownership of the company without prior permission of the State Government.
