With a view to provide more/direct bus service to the traveling public on the following routes falling on the Highways/Roads within the State of Punjab, based on the need got assessed from the offices of respective Secretary RTAs, applications are hereby invited from the intending applicants/general public who are natives of Punjab State, for the grant of regular stage carriage permits with return trips as mentioned against each route for big buses (having seating capacity of 39 or more) as per the provisions of the Punjab Transport Scheme 2018 dated 22.02.2018 as modified on 04.06.2019. As per the approved Transport Scheme, the stage carriage permits on the routes falling on National Highways and State Highways/Major District Roads/Other Roads shall be granted in favour of the STUs and the Private Operators in the ratio of 50:50 and 40:60 respectively. Separate application shall be made for each route:

days i.e. upto **14.12.2021** by **5.00 PM**. No application will be considered after the due date or which is incomplete or without the Demand Draft or fee.

Note: The applicants shall submit the hard copies of the applications duly signed by them along with demand draft etc. for the grant of the stage carriage permits on the routes to the offices of Secretary RTAs as mentioned below:

- a) From Sr. No. 1 to 9 to RTA, Bathinda.
- b) From Sr. No. 10 to 22 to RTA, Faridkot.

The last date for submission of applications: 14.12.2021 by 5.00 PM.
